TRANSFER OF COPYRIGHT AGREEMENT

The following Transfer Of Copyright Agreement applies to all originally created materials (as hereinafter defined) provided by Mr. Yahya Hautamäki and associated brandmarks (Al Haqq Society, Al Haqq Agency, Al Haqq Network) and their authorised representatives hereinafter named as "the Agency". Agreement is between the Agency and business or individual identified hereinafter as "the Client".

The Term Creative Material includes all materials created by the Agency and submitted to the Client, including without limitation, concepts, designs, scripts, plans or any other embodiments or expressions for advertisements in any media, point of purchase material, direct mail, websites, web advertisements, viral eMails, events, exhibitions, corporate identities, calendars, catalogues, brochures, posters, packaging, giveaways or any other marketing or promotional communications of any nature (and for the avoidance of doubt any third party materials which may be displayed as a suggested use of and in conjunction with the Creative Material, are not included).

Transfer Of Copyright Agreement is available through Agency websites and/or by the Client request.

The Agency hereby transfers, to the extent that there is copyright to be transferred, the exclusive copyright interest in the Creative Material in all subsequent editions of the the Creative Material, and in derivatives and translations including but not limited to illustrations, images, music, animation, tables, figures, graphs, movies, and other multimedia files, or in all formats and media of expression now known or later developed, including electronic, in full term thereof throughout the world to the Client subject to the following the Agency's Rights (as hereinafter defined) and to the Client's Rights (as hereinafter defined).

THE AGENCY'S RIGHTS

The Agency shall have the following rights:

- (1) All proprietary rights other than copyright, such as patent rights and intellectual property rights.
- (2) The Agency reserves the the nonexclusive right to photograph and/or distribute or publish for the Agency's promotional and marketing needs any of the Creative Material created for the Client, including mock-ups and comprehensive presentations, as samples for the Agency portfolio, website, newsletter, brochures, slide presentations and similar media.

THE CLIENT'S RIGHTS

The Client shall have the following rights:

- (1) The Client shall have the right to register copyright to the the Creative Material in its name as claimant, whether separately or as part of other proceedings or other medium in which the Creative Material is included.
- (2) The Client has the right to revise, adapt, prepare derivative works, publish, reprint, reproduce, and distribute the the Creative Material provided for the promotion of its business enterprise.

This Agreement, and the documents referred to in it, constitute the entire agreement and understanding of the Agency and the Client.

By signing this Agreement the Agency and the Client jointly and severally represent and warrant that the the Creative Material is original with the Agency and does not infringe any copyright or violate any other right of any third parties, and that the Creative Material has not been released elsewhere, and is not being considered for release elsewhere in any form, except as provided herein. The signing parties also represent and warrant that they have the full power to enter into this Transfer Of Copyright Agreement and to make the grants contained herein.
